Through a process facilitated by Mary Mollison, CSA, the assembly provided feedback that fell into five general categories. Members noted a desire for LCWR to focus on:

- Enhancing collaborative efforts of LCWR with other international and national organizations
- Exploring opportunities for restructuring LCWR
- Enhancing relationships between women religious leaders and US bishops
- Increasing awareness of US religious life through communications vehicles
- Providing resources for leadership development

At its post-assembly meeting, the LCWR board reviewed all the ideas surfaced by members during the assembly. Some of the key points noted included the following:

- Further education on the services and resources currently provided by LCWR may be helpful to the membership.
- Two types of thinking seemed to be in play during the assembly discussions: operational thinking and strategic thinking. The strategic questions are where LCWR now needs to focus its energy.

ics include:

- Building relationships between bishops and religious
- Heightening public awareness of women religious through the LCWR history exhibit, "Women & Spirit: Catholic Sisters in America"
- Exploring possible reconfiguration of LCWR regions
- LCWR's relationship with CICLSAL

The national board charged the LCWR executive committee and the national office staff to develop further steps for the shared future process. These steps will be discussed at the February meeting of the LCWR board.

From the LCWR Presidency Transitions and Constants

The national board appointed Pam Chiesa, PBVM treasurer at the completion of the term of Maryann Summa, OP. Mary Whited, CPPS completed her year as president, and I moved ahead into that responsibility of leadership.

Of course, members of LCWR are very aware of the major transition of the executive director of our

conference. Carole Shinnick, SSND kept the heart and the head of the conference integrated and moving with spirit, energy, and humor. With the completion of her two terms, the search was on for her successor. No easy task by any means! But, with the appointment of Jane Burke, SSND as the new executive director there is confidence of continued spirit and creativity.

We also cannot overlook the reality that half of the regional chairs have changed this year, reshaping the national board. WOW! This is more change and transition in leadership than LCWR has had for many years.



LCWR National Board Meeting Highlights

he LCWR national board met for one day prior to and three days after the assembly. The agenda items included:

- LCWR Shared Futures Process
- Evaluation of the LCWR-CMSM assembly
- Re-issuing the CARA inventory of policies, procedures, and practices regarding sexual abuse of minors
- Iraqi refugee trauma training
- Reports from the presidents, treasurer, executive director and national office staff
- Preparation for the LCWR regional meetings

At the meeting the board elected Katie Clauss, IHM and Nancy Reynolds, SP to serve one-year terms as the atlarge members of the executive committee.

Iraqi Refugee Trauma Training Project Begins

CWR members and associates have received information about the Catholic Relief Services Iraqi Refugee Trauma Training project which was an outcome of the January 2008 delegation of women religious, including an LCWR representative, to the Middle East. Having witnessed the anxiety, depression, and post-traumatic stress disorder experienced by so many refugees they met, delegates identified this program as one to be supported for financial assistance by constituents interested in assisting Iraqi refugees.

The project, which begins in the fall, will provide training in the United States for a core group of social workers in identifying the symptoms of trauma and appropriate interventions. The trainees will return to the Middle East to train other social workers in order to increase capacity. The goal of the project is to enhance ability to assist Iraqi refugees to address the impact of trauma on their lives, and to support their personal and communal well-being as well as their contributions to peacebuilding within their communities and nation.

New Video Released: They Killed Sister Dorothy

The new DVD traces the work of Dorothy Stang, SNDdeN that led to her shocking murder in February 2005, and follows the drama that unfolds at the trials of her killers. The 90-minute video has received awards at film festivals and is scheduled for an HBO release in February 2009, after which it will be available for showings in parishes, schools and universities, theaters, etc. Just Media worked in collaboration with Dorothy's family and religious community to produce this film about the sister whose life and work in the rainforests of Brazil inspired the filmmakers to tell a story they believe needs to be shared. LCWR Represented at National Gathering of Hispanic Sisters

ver to the far left near the sound technicians at the LCWR-CMSM 2008 assembly was a table with an assortment of men and women. Our conversations were deep,



fun, and provocative. In the end most of us exchanged addresses with the hope of keeping in touch. One Hispanic sister from nearby Pueblo, Colorado, a first-time LCWR assembly attendee, made some very insightful comments. As we got to talking during one of the breaks, she told us that some representatives from her community were going to a meeting the following week sponsored by the Archdiocese of Chicago and called by Joan McGlinchey, MSC, the archdiocesan vicar for religious. Because I am from Chicago, I was curious. I had noted the absence of significant numbers of Hispanic sisters at the assembly, so I went to find Joan to get more details about the forthcoming meeting and asked if I could attend part of the meeting as an observer. When I mentioned this at the LCWR post-assembly board meeting, the board designated me to attend as LCWR's representative and to report back to the board about the experience.

The day after I returned to Chicago from the board meeting, I joined the Hispanic sisters at the Cabrini Retreat Center for their first meeting with Francis Cardinal George. Twenty-eight of the 38 communities who received an invitation to the meeting were in attendance. These communities were from all over the country. Most, though not all, have motherhouses outside of the US. Joan McGlinchey, the initiator of this meeting, applied for and received an education grant from the National Religious Retirement Office.

In animated dialogue with one another, as well as with Cardinal George, Bishop Gustavo Garcia–Siller (auxiliary bishop of Chicago), and with representatives from LCWR, the Center for the Study of Religious Life, and NRRO, this group of women expressed a desire to continue to meet locally, regionally, and nationally. They want to invite other Hispanic Sisters into the conversation. Joan estimates that this meeting may have only reached half of the Hispanic communities in this country.

What was clear is that members of this group found their voice, expressed their feelings of being isolated, and shared their desires to be in connection with other groups, such as LCWR, within the church. Their designated representatives will meet to plan next steps in early 2009 in Los Angeles.

The Mission of LCWR

- Fostering dialogue and collaboration among religious congregations within the church and in the larger society.
- Developing models for initiating and strengthening relationships with groups concerned with the needs of society, thereby maximizing the potential of the conference for effecting change.

The Leadership Conference of Women Religious has established the LCWR Outstanding Leadership Award to recognize and honor persons who have significantly contributed to the ministry of leadership and who reflect the LCWR mission.

Nomination

National members of the Leadership Conference for Women Religious may nominate a person for consideration for the LCWR Outstanding Leadership Award.

Criteria for the Award

The person must have significantly contributed to the

ministry of leadership in a manner that reflects the mission of LCWR. The nominee(s) evidence:

- Commitment and collaboration in the ministry of leadership
- Faithfulness to gospel values and mission
- Witnessing to creative and innovative leadership in one or more areas
- Making significant contribution, as a leader on the national and/or international level, particularly to women religious congregations in the United States

LCWR Members Invited to Attend the NATRI-LRCR Conference

rom November 18 to 21, 2008 NATRI and LRCR will be hosting a joint conference in Denver with the theme of "New Beginnings: Emerging Realities." One of the emerging realities that this conference heralds is the coming merger of these two service organizations into a single entity. The conference combines the educative work of these organizations. Members of the Leadership Conference of Women Religious will find 47 presentations to choose from. The keynote address on November 18 will be given by Dean Carolyn Woo, PhD of the Mendoza College of Business at the University of Notre Dame, who will focus on the preparation of lay leadership and the emerging social agenda of the private sector.

A second major address by Lynn Jarrell, OSU, JCD, president of the Ursuline Sisters of Louisville, KY and Daniel Ward, OSB, executive director of the Legal Resource Center for Religious, will look at challenges in maintaining a balanced relationship between diocese and institutes/societies.

Other topics of interest range from alternate investments and advanced topics in accounting to Social Security and stress management.

There will be four pre-conference workshops on November 18. One is a legal conference presented by Christine Rody, SC, JCL and Simone Campbell, SSS, JD. The NATRI projection software TRENDS will be featured in a hands-on session for beginners led by Laura Reicks, RSM and another for experienced users presented by Hertha Longo, CSA. There will also be a free small group gathering from 1:00 to 3:00 PM that same day.
